A: City of Hamilton: Councillor Maureen Wilson

- Main Street West changes update. Motion passed end of May overwhelming majority to support, with 3 parts to the changes:
 - Engineering immediate changes. Objectives to address history of collisions.
 Abnormal number of sideswipes multiple lane changes, speed, synchronized light. Hatch mark south side for pedestrians, 5 to 4 lanes, no right on red, advanced lights on pedestrians. Work is proceeding on King same rules, no right on red, priority to bus, changes to King @ Dundurn and Main @ Dundrun. Review with video analytics.
 - 2. 2023 main Main and King two way.
 - 3. Proceed with other roads in Master Plan for 2 way traffic.
 - A few concerns raised:
 - Stop at red lights. Think causing aggravation. No right on red. Delegated authority from City president of traffic. Repeat collision, city safety measures, protect vulnerable users.
 - Main Left at Locke needs signs to tell others earlier that left turn only
 - Entering off 403, maybe solid line so no getting over 4 lanes
 - Another light or crosswalk on Main Before Locke and Dundurn
- Comment: homeless issues, concerns for businesses for safety and security Health crisis and housing crisis, no short-term solution.
- Paid parking shortfall COVID deficit.
 - o Christmas free parking program keep same NOV 24-DEC 24, effort to keep
 - Thank you Councillor for keeping Shared Parking revenue same for BIAs
